APPROVED APPLICATIONS:

Trade Name: Flame and Ember Resistant Off-Ridge Attic Vent for Clay and Concrete Tile

System Type A: Mechanical attachment of vent under tile.

Slot: Starting approximately 18" down the ridge and a minimum 12" from the edges, mark a 19" x

7" opening centered between layout lines and align approximately as shown on exposure lines as seen in Detail B. Set blade to thickness of sheathing and cut opening. Brush away

sawdust and debris.

Installation: Set primary vent over the opening and secure with corrosion resistant 12ga., 1 1/4" galvanized

ring shank roofing nails around the vent flange at 4"o.c. Nails shall be of sufficient length to

penetrate through the sheathing a minimum of ³/₁₆". Seal the primary vent to the

underlayment with a Miami Dade approved ASTM D 4586 asphalt roofing cement and

Miami Dade approved ASTM D1668 fabric.

Install secondary vent over the primary vent by centering it over the primary vent and bending the wind clip tightly under the preceding course of tile. Each secondary vent will replace 2 field tiles. Secure secondary vent to the roof deck with two (2) corrosion resistant 12ga. 1 ¼" galvanized ring shank roofing nails in the manufacturer's designated locations. Nails shall be of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ".

Seal the secondary vent to the preceding course of tile with min. 1/2" bead of an approved

Miami Dade ASTM C920 sealant.

Ventilation Calculations:

See manufacturer's published literature for net free area.

- 1. Refer to applicable Building Code required ventilation.
- 2. The installation shall be applied in compliance with the manufacturer's current published application instruction and the requirements set forth in the applicable building code.
- 3. O'Hagin's Flame and Ember Resistant Off-Ridge Attic Vent for Clay and Concrete Tile is approved to be installed over clay or concrete roof tiles only.
- 4. O'Hagin's Flame and Ember Resistant Off-Ridge Attic Vent for Clay and Concrete Tile shall not be installed on roof mean heights greater than 40 ft.
- 5. Do not install vents below or adjacent to valleys or other areas of concentrated water runoff.
- 6. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 7. All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.









PRIMARY VENT (SUBFLASHING)




HIGH 'S' PROFILE VENT





FLAT PROFILE VENT




MODEL 'S' & 'M' PROFILE VENTS FOR 1-PIECE TILES



 MARK & CUT a 19" x 7" hole in the roof deck, centered between layout lines and aligned approximately as shown on the exposure lines. (Note: set blade to the thickness of the sheathing).




2. **SEAL** using a Miami Dade approved sealant (Class A where required by code for flame resistance) around outer flange of primary vent.




3. ATTACH at 4"o.c. using roofing nails of sufficient length to penetrate the sheathing



4. FLASH. See general installation notes. When using an approved Miami Dade peel and stick or membrane and mastic methods, apply bottom strip first, then sides and, finally, the top strip.



5. INSTALL secondary vent cover. (For "M" style vents only on medium profile tiles, insert tile between perforated top of secondary vent cover and bottom flanged water channel – see inset). Bend the wind clip tightly under the preceding course of tile, adjusting for head lap.




6. SECURE with roofing nails of sufficient length to penetrate sheathing. SEAL any gaps between the secondary vent cover and surrounding tiles using a Miami Dade approved sealant (Class A where required by code for flame resistance).

MODEL 'FLAT' PROFILE VENTS FOR FLAT TILES



- 1. Follow steps 1-4 of the 1-piece installation instructions.
- 2. Tile is the inserted between louvered top of secondary vent cover and bottom flange water channel (see inset). Bend the wind clip tightly under the preceding course of tile, adjusting for head lap. Remove 2" to 3" of the tile batten lug on either side the secondary vent cover for proper fit. For tiles with continuous lugs, a portion of the lug may be removed as needed for wind clip installation. The secondary vent cover takes place of two field tiles.
- 3. Secure and seal as shown in Step 6 of the 1-piece installation instructions. Seal the underside of secondary vent and top of tile below with an approved sealant (Class A where required by code for flame resistance).
